6. Accidental release measures

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.

7. Handling and storage

Precautions for safe handling:

Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Do not get in eyes. Wash hands thoroughly after handling. Avoid contact with skin.
