6. Accidental release measures

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. In case of leakage, eliminate all ignition sources. Dike far ahead of larger spill for later recovery and disposal. Use non-sparking

tools.

Environmental Precautions:

Prevent further leakage or spillage if safe to do so.

Precautions for safe handling:

Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container. Take precautionary measures against static discharges.
