**Precautions for safe handling:**

Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container. Avoid contact with eyes, skin, and clothing. Wash hands thoroughly after handling.

Store in original tightly closed container. Avoid contact with oxidizing agents. Store away from incompatible materials.

### Protective Measures:
