6. Accidental release measures

Methods and material for containment and cleaning up:

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal. In case of leakage, eliminate all ignition sources. Use non-sparking tools.

7. Handling and storage

Precautions for safe handling: Observe good industrial hygiene practices. Wear appropriate personal

protective equipment. Do not expose to intense heat as product may expand and pressurize container. Do not get in eyes. Wash hands thoroughly after handling. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Ground and bond container and receiving equipment. Take precautionary measures against static

discharges. Avoid contact with skin.
