Precautionary Statements

4. First-aid measures

5. Fire-fighting measures

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures: ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Ensure adequate ventilation. Keep unauthorized personnel away. See Section 8 of the SDS for Personal Protective Equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them.

Methods and material for containment and cleaning up: Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal. In case of leakage, eliminate all ignition sources. Use non-sparking tools.

Environmental Precautions: Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.

7. Handling and storage

Precautions for safe handling: Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container. Do not get in eyes. Wash hands thoroughly after handling. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Ground and bond container and receiving equipment. Take precautionary measures against static discharges. Avoid contact with skin.

Conditions for safe storage, including any incompatibilities: Store in a well-ventilated place. Store in a cool place. Flammable liquid storage.
