6. Accidental release measures

Personal precautions, protective equipment and emergency procedures:

Methods and material for containment and cleaning up:

Absorb spill with an inert material, then place in a container for safe and proper disposal. Dike far ahead of larger spill for later recovery and disposal. Eliminate all ignition sources if safe to do so. Use only non-sparking tools.

Environmental Precautions:

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so and protect against releases into the environment. Remediate as appropriate. Avoid release to the environment.
