Methods and material for containment and cleaning up:

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. In case of leakage, eliminate all ignition sources. Dike far ahead of larger spill for later recovery and disposal. Use non-sparking tools.

Environmental Precautions:

Avoid release to the environment. Prevent further leakage or spillage if safe

to do so.

7. Handling and storage

Precautions for safe handling: Observe good industrial hygiene practices. Wear appropriate personal

protective equipment. Do not expose to intense heat as product may expand and pressurize container. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Ground and bond container and receiving equipment. Take precautionary measures

against static discharges.

Conditions for safe storage, including any incompatibilities:

Store in original tightly closed container. Avoid contact with oxidizing agents. Store away from incompatible materials. Store locked up. Store in a well-ventilated place. Store in a cool place. Flammable liquid storage.
