6. Accidental release measures

Methods and material for containment and cleaning up:

Absorb spill with an inert material, then place in a container for safe and proper disposal. Eliminate all ignition sources if safe to do so. Dike far ahead of larger spill for later recovery and disposal. Use only non-sparking tools.

Environmental Precautions:

Prevent further leakage or spillage if safe to do so and protect against releases into the environment. Remediate as appropriate.

7. Handling and storage

Precautions for safe handling:

Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Ground/bond container and receiving equipment. Take precautionary measures against static discharges.
