Ventilate closed spaces before entering them.

Methods and material for containment and cleaning up:

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Eliminate all ignition sources if safe to do so. Dike far ahead of larger spill for later recovery and disposal. Use only non-sparking tools

Environmental Precautions:

Prevent further leakage or spillage if safe to do so.

7. Handling and storage

Precautions for safe handling:

Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container.
