Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. In case of leakage, eliminate all ignition sources. Dike far ahead of larger spill for later recovery and disposal. Use non-sparking tools.

Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Ground and bond container and receiving equipment.
