Ventilate closed spaces before entering them. See Section 8 of the SDS for Personal Protective Equipment. Keep upwind. Keep unauthorized personnel away. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

**Methods and material for
containment and cleaning
up:**

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

Environmental Precautions:

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so. Avoid release to the environment.

7. Handling and storage

Precautions for safe handling:

Provide adequate ventilation. Wear appropriate personal protective equipment. Observe good industrial hygiene practices. Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Contains a component that when heated at or above 300F (150C) may generate Formaldehyde vapors. Wash hands thoroughly after handling. Add material slowly when mixing with water. Do not add water to the material; instead, add the material to the water. Avoid contact with skin.
