## 7. Handling and storage

**Precautions for safe handling:** Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container. Avoid contact with eyes. Wash hands thoroughly after handling. Add material slowly when mixing with water. Do not add water to the material; instead, add the material to the water. Do not handle until all safety precautions have been read and understood. Obtain special instructions before use. Use personal protective equipment as required.

**Conditions for safe storage, including any incompatibilities:** Store in original tightly closed container. Avoid contact with oxidizing agents. Store away from incompatible materials. Store locked up.
