Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

7. Handling and storage

Precautions for safe handling:

End-users should follow industry best practices for handling and using this product.

Guidance may be found using the current version of ASTM Standard E1497-05: Standard Practice for Selection and Safe Use of Water-Miscible and Straight Oil Metal Removal Fluids Provide adequate ventilation. Observe good industrial hygiene practices. Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Wash hands thoroughly after handling. Add material slowly when mixing with water. Do not add water to the material; instead, add the material to the water. Do not handle until all safety precautions have been read and understood. Obtain special instructions before use. Use personal protective equipment as required. Avoid contact with skin.
