**Methods and material for containment and cleaning up:** Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

**Environmental Precautions:** Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.

## 7. Handling and storage

**Precautions for safe handling:** End-users should follow industry best practices for handling and using this product.

Guidance may be found using the current version of ASTM Standard E1497-05: Standard Practice for Selection and Safe Use of Water-Miscible and Straight Oil Metal Removal Fluids Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Contains a component that when heated at or above 300F (150C) may generate Formaldehyde vapors. Avoid contact with eyes. Wash hands thoroughly after handling. Add material slowly when mixing with water. Do not add water to the material; instead, add the material to the water.

**Conditions for safe storage, including any incompatibilities:** Keep container tightly closed. Store locked up. Store in a well-ventilated place.
