Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Contains a component that when heated at or above 300F (150C) may generate Formaldehyde vapors. Do not get in eyes. Wash hands thoroughly after handling. Use caution when adding this material to water. Add material slowly when mixing with water.
