Do not get in eyes, on skin, on clothing. Use caution when adding this material to water. Add material slowly when mixing with water. Do not add water to the material; instead, add the material to the water. Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines.
