Methods and material for containment and cleaning

up:

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

7. Handling and storage

Precautions for safe handling: Provide adequate ventilation. Wear appropriate personal protective

equipment. Observe good industrial hygiene practices. Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Do not get in eyes.
