6. Accidental release measures

Methods and material for containment and cleaning up:

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

Environmental Precautions:

Avoid release to the environment. Prevent further leakage or spillage if safe to do so. Do not contaminate water sources or sewer.

7. Handling and storage

Precautions for safe handling:

Observe good industrial hygiene practices. Avoid contact with eyes. Wash hands thoroughly after handling. Do not expose to intense heat as product may expand and pressurize container. Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Contains a component that when heated at or above 300F (150C) may generate Formaldehyde vapors. Do not handle until all safety precautions have been read and understood. Obtain special instructions before use. Use personal protective equipment as required. Avoid contact with skin.
