6. Accidental release measures

Methods and material for containment and cleaning up: Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Eliminate all ignition sources if safe to do so. Dike far ahead of larger spill for later recovery and disposal. Use only non-sparking tools.

Environmental Precautions: Prevent further leakage or spillage if safe to do so.
