Precautions for safe handling:

Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container. Do not get in eyes. Wash hands thoroughly after handling. Use caution when adding this material to water. Add material slowly when mixing with water.
