## 7. Handling and storage

**Precautions for safe handling:**

Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container. Contains amines. Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Wash hands thoroughly after handling. Add material slowly when mixing with water. Do not add water to the material; instead, add the material to the water. Avoid contact with eyes, skin, and clothing.
