### **5. Fire-fighting measures**

### **6. Accidental release measures**

<b>Personal precautions, protective equipment and emergency procedures:</b>	Ventilate closed spaces before entering them. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Keep upwind. Keep unauthorized personnel away. Ensure adequate ventilation. See Section 8 of the SDS for Personal Protective Equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.
<b>Methods and material for containment and cleaning up:</b>	Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. In case of leakage, eliminate all ignition sources. Dike far ahead of larger spill for later recovery and disposal. Use non-sparking tools.
<b>Environmental Precautions:</b>	Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.

<b>Precautions for safe handling:</b>	End-users should follow industry best practices for handling and using this product.
