### **5. Fire-fighting measures**

Ensure adequate ventilation. See Section 8 of the SDS for Personal Protective Equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

**Methods and material for  
containment and cleaning  
up:**

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. In case of leakage, eliminate all ignition sources. Dike far ahead of larger spill for later recovery and disposal. Use non-sparking tools.

**Environmental Precautions:**

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.
