6. Accidental release measures

Methods and material for containment and cleaning up: Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Dike far ahead of larger spill for later recovery and disposal.

7. Handling and storage

Do not add sodium nitrite or other nitrosating agents which may form cancer causing nitrosamines. Do not handle until all safety precautions have been read and understood. Obtain special instructions before use. Avoid contact with eyes. Wash hands thoroughly after handling. Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container.
