## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures:

Ventilate closed spaces before entering them. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Keep upwind. Keep unauthorized personnel away. Ensure adequate ventilation. See Section 8 of the SDS for Personal Protective Equipment. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing.

### Methods and material for containment and cleaning up:

Absorb spill with vermiculite or other inert material, then place in a container for chemical waste. Eliminate all ignition sources if safe to do so. Dike far ahead of larger spill for later recovery and disposal. Use only non-sparking tools.

### Environmental Precautions:

Do not contaminate water sources or sewer. Prevent further leakage or spillage if safe to do so.

## 7. Handling and storage

### Precautions for safe handling:

Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container.
