Reproductive toxicity

Product:

This product contains Borax (disodium tetraborate). Animal feeding studies in rat, mouse, and dog, at high doses, have demonstrated effects on fertility and testes. Studies with chemically related boric acid in rat, mouse and rabbit, at high doses, demonstrate developmental effects on the fetus including fetal weight loss and minor skeletal variations. The doses administered were many times in excess of those which humans would normally be exposed to. An epidemiology study under the conditions of normal occupation exposure to borate dusts indicated no effect on fertility.

In the European Union, disodium tetraborates are listed in the Annex XVII of REACH Regulation 1907/2006 and its use in consumer products above specific concentration limits (SQL) is restricted. Disodium tetraborates can be used in consumer products below its SQL, which is greater or equal to 8.5% for Borax decahydrate. Suspected of damaging fertility or the unborn child. A human study of occupationally exposed borate worker population showed no adverse reproductive effects. Animal studies indicate that boric acid reduces or inhibits sperm production, cause testicular atrophy, and when given to pregnant animals during gestation, may cause developmental changes. These feed studies were conducted under chronic exposure conditions leading to doses many times in excess of those that could occur through inhalation of dust in the occupational setting.
