**Personal precautions, protective equipment and emergency procedures:**

Ventilate closed spaces before entering them. See Section 8 of the SDS for Personal Protective Equipment. Keep upwind. Keep unauthorized personnel away. Do not handle damaged containers or spilled material unless wearing appropriate protective clothing.
