6. Accidental release measures

7. Handling and storage

Precautions for safe handling: Contains amines. Do not add sodium nitrite or other nitrosating agents

which may form cancer causing nitrosamines. Contains a component that when heated at or above 300F (150C) may generate Formaldehyde vapors. Observe good industrial hygiene practices. Wear appropriate personal protective equipment. Do not expose to intense heat as product may expand and pressurize container. Wash hands thoroughly after handling.
