Section 3: Hazard Identification

Neutralize this mixture with 5% Hydrochloric Acid, let stand overnight, then pour the liquid into the drain while flushing with water. Dispose of any solid with normal refuse. Wash the area of the spill with plenty of water.

As with all chemicals, wash hands thoroughly after handling. Avoid contact with eyes and skin. Protect from freezing and physical damage. Store below 25°C. Empty containers may be hazardous since they retain product residues.
